Competition Terms and Conditions

1. Competition starts 9am Monday 1st April 2019 and closes at 5pm Sunday 21st April 2019.
2. Information on how to enter and prizes form part of the Conditions of Entry. Entry into this competition deems acceptance of these Conditions of Entry.
3. Entry is open to all residents of Western Australia aged 18 years and above, except Centre staff, their families, agents and contractors of Primewest Cottesloe Central Shopping Centre, who are not eligible to enter this competition.
4. To enter this competition, customers must either:
 - a) Make a purchase of \$30 or more from any specialty store or \$100 from Woolworths or Bunnings at Primewest Cottesloe Central Shopping Centre during the promotional period, collect an *Entry Form*, complete details in full on *Entry Form* (including entrants full name, address, phone and email address), attach a valid shopping receipt, then place the completed *Entry Form* into the entry box located in the main mall of the shopping centre.
 - b) Cut out the '*Bonus Entry Coupon*' from the Primewest Cottesloe Central Easter 2019 flyer, complete the details in full and place the *Bonus Entry Coupon* into the entry box in centre (ie. no purchase necessary for the Bonus Entry Coupon).
5. Only original '*Easter Getaway Competition*' *Entry Forms* will be accepted; photocopies will not be accepted.
6. Multiple entries will be accepted provided the minimum spend condition occurs with each entry and a valid receipt is attached to each *Entry Form* (as outlined in Clause 4a).
7. Multiple entries of the Bonus Entry Coupon will not be accepted.
8. Entries received via post will not be accepted.
